

TRAVEL POLICIES

1. **MEDICALS/WAIVERS:** All travelers are required to complete and sign a Medical form and Waiver of Liability form PRIOR to traveling with Adventure Sports LLC. Adventure Sports LLC reserves the right to require a complete medical examination, at the expense of the traveler, prior to travel. Adventure Sports LLC reserves the right to refuse acceptance of a traveler for any reason whatsoever.
2. **DROP DEAD DATE:** Each trip has a "DROP DEAD DATE" for accepting travelers. Acceptance of a traveler after the "DROP DEAD DATE" may involve an increase in price for airfare, hotel or other services.
3. **GOLD KEY PRICING:** GOLD KEY members must sign-up (pay deposit due) by the "GOLD KEY DEADLINE" in order to take advantage of the Gold Key Travel Discount.
4. **DEPOSITS:** A deposit is required for all travel. The deposit is due and payable at sign-up. Travelers are NOT signed-up on a particular trip until the deposit is received. All deposits are nonrefundable and nontransferable.
5. **PAYMENTS:** A payment schedule is provided for each trip. Payments dates are firm and the balance MUST be received on or before the "DROP DEAD DATE".
6. **CANCELLATION:** Occasionally, due to remoteness of location and/or prevailing weather conditions, there may be a modification to portions of the itinerary. Adventure Sports LLC attempts to accommodate everyone to the best of its ability. No refunds can be made for canceled diving arrangements due to adverse weather, or for substitutions of facilities and/or equipment or for minor inconvenience.
7. **INSURANCE:** Trip cancellation insurance is available. Ask for a brochure. Generally this insurance policy is valid only for illness or death. Read your policy thoroughly before buying - know before you buy.
8. **REFUNDS:** Cancellation terms differ with each destination and carrier. When possible, a refund of all but the deposit will be made.
9. **RELEASE AND ABSOLUTION:** In order to participate in Adventure Sports LLC travel opportunities, traveler must agree that in consideration of the price at which the said program is offered and conducted and other goods and valuable considerations, and in order to induce Adventure Sports LLC to accept the traveler as a member of such program, the traveler or the traveler's parent or guardian of traveler under the age of majority, release and absolve Adventure Sports LLC and the agents and employees thereof from any and all liability for property loss, or damage, and/or from any and all damages resulting from death or personal injuries including loss of services, which we or either of us may sustain on account of, arising out of, or in connection with said program, whether resulting from negligence or anyone in charge of or participating in said program or from the ownership, maintenance, use, operation or control of any automobile, ship, airplane, bicycle, boat, vehicle, inn, hotel, common carrier, or otherwise.
10. **CONTINUING EDUCATION:** Fees for any SCUBA training and SCUBA continuing education classes are to be separate from the price at which this trip is offered and conducted.
11. **CREDIT CARD CHARGES:** There is a 3% surcharge when using a credit card to pay for travel.
12. **PRICES:** Any fees estimated or projected will be identified as such. The payment of the initial deposit locks traveler into a firm price for travel. Any initial deposits received within 60 days of departure are subject to any increases which may have occurred as a result of signing-up within 60 days of departure.
13. **USE OF OUTSIDE SERVICE PROVIDERS:** Adventure Sports LLC absolutely does not accept or assume any responsibility or liability for the services, personnel, or equipment of any kind of any service provider such as hotels, airlines, ground transportation, dive facilities, tour guides, dive leaders and the like.
14. **ITINERARIES:** An itinerary will be provided to each traveler listing the anticipated schedule, contact information, travel dates and other important information. Itineraries are subject to change without notice.
